Any person desiring to be a candidate for a position on the Northwest Arkansas Community College Board of Trustees will:

- File a notarized Statement of Candidacy
- Pay a Ballot Fee of \$3.00
- File a Petition containing the signatures of at least twenty-five (25) qualified electors of the zone requesting that the name of such person be placed on the ballot as a candidate for the position on the board.
- Run by zone
- Be elected on a nonpartisan basis
- Must be a resident of the respective School District within Zone.

THE DEADLINE FOR FILING AS A CANDIDATE IS 12:00 NOON ON AUGUST 19, 2016
