BE IT RESOLVED BY THE QUORUM COURT OF THE COUNTY OF BENTON, STATE OF ARKANSAS, A RESOLUTION TO BE ENTITLED:

**A RESOLUTION EXPRESSING THE WILLINGNESS OF BENTON COUNTY TO UTILIZE FEDERAL-AID SURFACE TRANSPORTATION PROGRAM – ATTRIBUTABLE (STP-A) FUNDS ADMINISTERED BY THE NORTHWEST ARKANSAS REGIONAL PLANNING COMMISSION FOR DESIGN COSTS IN CONNECTION WITH THE REPAIR OF WAR EAGLE BRIDGE**

**WHEREAS**, the Benton County Quorum Court acknowledges that Federal-aid Surface Transportation Program - Attributable Funds are available at 80% federal participation and 20% local match for costs to repair War Eagle Bridge; and

**WHEREAS**, the Benton County Quorum Court acknowledges that Federal-aid Funds are available for this project on a reimbursable basis, requiring work to be accomplished and proof of payment prior to actual monetary reimbursement, and

**WHEREAS**, the Benton County Quorum Court acknowledges the estimated costs to repair War Eagle Bridge are \$300,000.00, meaning that, if approved, the County will be eligible for reimbursement of an estimated \$240,000.00 and making the Counties estimated share of costs \$60,000.00.

**WHEREAS**, this project, using federal funding, will be open and available for use by the general public and maintained by the applicants.

**NOW, THEREFORE, BE IT RESOLVED BY THE QUORUM COURT OF BENTON COUNTY, ARKANSAS THAT:**

**ARTICLE 1:** The Benton County Quorum Court expresses its willingness to participate in the above described project, in accordance with its designated financial responsibility, including maintenance of its portion of this project.

**ARTICLE 2:** The Benton County Judge is hereby authorized to execute all appropriate agreements and contracts necessary to expedite the above described project.

**ARTICLE 3:** The Benton County Quorum Court pledges its full support and hereby authorizes the Benton County Judge to cooperate with the Northwest Arkansas Regional Planning Commission to initiate action to implement this project.
